***AGE REQUIREMENTS**

I understand that I must be a minimum of 16 years old by first phase of competition, which is June 26, 2017. I understand that I have not achieved my 22nd birthday by January 1 of the year in which I would compete in the Miss Illinois county Fair Queen Pageant 2018.

***STATUS**

I am not married, divorced, or had a marriage annulled. I am not pregnant, nor have ever been pregnant. I am not the adoptive parent of any child. May not be living with a boyfriend or significant other.

***RESIDENCY REQUIREMENTS**

I must reach one of the requirements of residency to compete. Have a permanent Ford County address, attend or have graduated from a Ford county school or currently be a member of a Ford county 4-H Club.

***CONDUCT**

Other than minor traffic offenses, I have never been convicted of any crimes and there are no adjudications presently pending against me.

I do not use, consume, or abuse the use of any alcohol, tobacco, or other controlled substances. I may not partake in the use of tobacco, alcohol, or any controlled substances, while vying for the title of Miss Ford County. These regulations will also continue to whomever is chosen as Miss Ford County.

I must have conduct becoming of a queen contestant and Miss Ford County at all times, including but not limited

to information, comments, blogs, or photographs in person, on the phone, or on internet sites. Any attitudes, actions, or activities perceived as conduct unbecoming of a queen contestant and Miss Ford County may result in immediate removal of the entrant from the contest or title at the discretion of the Pageant directors. I will agree to participate in public relations for the Ford County Fair, the Ford County Fair Queen Pageant, and Ford County. Appearances include, but not limited to, other county fairs pageants, parades, County Fair Day at the Illinois State fair in August, radio interviews, newspaper releases and other media deemed necessary and appropriate.

I also agree to the set forth attendance policy: Unless otherwise stated on your schedule or by the Pageant Directors, attendance is considered mandatory to all practices (as noted) and events. It is extremely important that I arrive to all practices and events promptly on time.

I agree to cover all visible tattoos with cosmetics or a band-aid for competition. I also understand to limit piercing jewelry to a maximum of two in each ear lobe only. All other body piercing jewelry must be removed for competition.

ALL CLOTHING MUST be approved by the Pageant Directors at County and State level.

I agree to work exclusively with only Ford County Pageant Directors in preparation for County and State Level.

In case of a marriage, pregnancy, or in any other reason I am unable to fulfill my obligations as an Entrant; I agree to relinquish all privilege and prizes awarded, upon the direction of the Pageant Directors. Convictions of any crime, other than a minor traffic offense, shall be cause for recall.

It is understood that the selected contestant to win the title of Miss Ford County will be required to compete at the Illinois Association of Agricultural fairs Queen Pageant in January 2018, and must be available from the Thursday preceding the competition to the Monday following the competition. This trip will be at the expense of the Fair Board, the queen shall incur no costs other than wardrobe, personal telephone calls, and other purchases that are made such as, videotapes and official pageant photographs. Two (2) tickets to the Sunday night finals and banquet will be provided free of charge to the Queens parents or guardian, etc.. All other tickets are to be purchased by the user. While competing at the Illinois Association of Agricultural Fair Queen Pageant, it is expected for Miss Ford County to abide by the rules and regulations and to compete with the utmost sportsmanship.
